TERMS & CONDITIONS

SPRING BREAK SERVICE AGREEMENT TERMS:

SMW Enterprizes Inc, located at 113 McHenry Rd., Buffalo Grove, IL 60089, dba HighSchoolVacations.com, herein referred to as HSV, has arranged the vacation packages described in this brochure/flier/invoice/website/confirmation. All checks or money orders are to be payable to High School Vacations. Subject to the terms of this Services Agreement, (the "Services Agreement" or "Agreement"). HSV and its Licensors make available online information and services to HighSchoolVacations.com customers. By signing the bottom of this form, you are indicating that you are bound by all of the terms in this Agreement. The term "using" means the use and availability of, access to, transmission to or from or any exchange of information or communication in connection with or arising from the Site(s). You may print and keep a copy of this Agreement. HSV may change the terms in this Agreement at any time. Any changes will appear in this document, which you can access at any time by returning to this page. It is your responsibility as a user to refer to the terms on accessing the Site(s). Changes will be effective the day after first posting to the Site(s) and you will be deemed to have accepted any change if you continue to access the Site(s) after that time.

PACKAGE PRICES/INCLUSIONS:

View our Brochure/Flyer/Invoice/Website/Confirmation for Package Inclusions. All package inclusions are subject to the terms and conditions contained herein. Unless indicated otherwise in our brochure/flier/website/invoice/confirmation, land only packages, hotel only packages, and cruise packages may not include transportation. Package prices are based on current rates at time of booking, and are subject to change, without notice, due to, but not limited to increases in airline fuel, available class of service with airline, government taxes/fees, etc. Any fuel related increases and/or changes in government taxes/fees will be assessed at least 10 days prior to departure and must be paid by all passengers, regardless of whether account is paid in full or not. Certain items (i.e. T-shirts, back packs, discounts, etc) are subject to change at suppliers' discretion, and any change will not require a refund or credit by tour operator or its agents. All vacation participants traveling with HSV, understand these packages are both directed and geared toward high school students who are flexible with somewhat flexible travel plans.

RESERVATIONS AND PAYMENTS:

A \$300 per person deposit is required to make your reservation. A second \$300 payment is due 160 days prior to departure. The final payment is due 100 days prior to departure. Payment of your deposit constitutes full acceptance and understanding of HSV's terms and conditions. Any change to your reservation once under deposit, will result in a \$75 HSV fee per person, plus any additional costs by suppliers. Reservations not paid in full on time are subject to cancellation, and all cancellation penalties will apply. Late payments also risk loss of first choice of hotel/flight, as well as possible late fees starting at \$50 per person. The first two deposit payments are payable to HSV by check only. The final payment can be paid by check or credit card.

You agree to pay or have paid all fees and charges incurred in connection with your reservation. If you pay by credit card or other payment instrument and HSV does not obtain full payment, you agree to pay all amounts due upon our demand. You are responsible for any fees or charges incurred by you for any Internet access provider or other third-party service. You, and not HSV, are responsible for paying any amounts billed to your credit card by a third party, which were not authorized by you. If you provide payment for our services by a third party, and they decline to make such payment, you will still be liable for monies owed, and all legal fees we may incur from collecting such payment. Any outstanding balance due to HSV will be collected either through the vacation participant directly, or through legal services, in which the vacation participant will be responsible for their balance, and all lawyer and legal fees/charges/costs resulting from such an action. Vacation participant and HSV agree to resolve any dispute in a court of competent jurisdiction in Lake County – Illinois only. There is a \$75 HSV service fee to reinstate any reservation that has been canceled, plus any additional fees/costs from suppliers, IF space is still available. There is a \$50 fee for any check returned to HSV as insufficient funds or stop payment, and a \$15 fee for any credit card(s) that are declined more than two times for the same deposit. You are responsible for finding your own roommates. If your roommate(s) cancels, you and your remaining roommate(s) must pay applicable occupancy changes and fees due to the cancellation, prior to the departure date.

All travel documents and flight information on your trip will be available to you approximately 7 days prior to departure, BUT will not be sent until FULL PAYMENT and a signed copy of our Terms & Conditions has been received in our office from all passengers in the same room or Group Reservation. Unless your trip requires actual ticket documents, you must print your E Tickets. Actual travel documents mailed to you, could have an extra fee involved. HSV will not be responsible for undelivered or misdirected mail or email.

DEPARTURE CITIES AND AIRCRAFTS:

The following are considered Co-Terminal Airports when booking... (LaGuardia/JFK/Newark), (BWI, DCA, IAD), (ORD, Midway, Milwaukee), (Detroit Metro, City), (Orlando, Jacksonville), (Miami, FLL), (Rochester, Syracuse, Buffalo), (Cincinnati, Dayton), which means your trip can leave/depart from any co-terminal at the option of HSV. We will do our best to get you out of the airport requested, but a change in your airport choice will not constitute a reason for cancellation with refund or any compensation. All air transportation is used with either chartered aircrafts, or regular scheduled air, and we do not guarantee single plane or non-stop service. If you have any questions on our flights, please call us for further information.

BAGGAGE/LOST or DELAYED BAGGAGE:

Air carriers allow each tour participant to bring one (1) piece of luggage, each measuring no more than 62 inches and a maximum of 44 pounds, plus one carry-on bag that can fit under the seat in front of you. For delayed baggage, air carrier liability is limited. Air carriers and HSV have no responsibility, financial or otherwise, to passengers who fail to submit a lost baggage claim form to their air carrier within 24 hours of arrival. HOTEL SECURITY DAMAGE DEPOSITS:

\$25-\$100 per person deposit will be collected at the hotel upon check in. This deposit is required by the hotel and refundable by the hotel at check out, if you do not damage your hotel room, or any of its property, unless otherwise stated. HSV is not responsible for any damages charged to its vacation participants, nor shall it refund any money that was not refunded to them by the hotel, due to hotel policies, theft, misplacement, etc.

FLIGHT DELAYS:

Flight delays are unfortunate, but they are a risk in all air travel and beyond the control and responsibility of HSV. Flight delays, missed night(s) accommodations and expenses incurred due to flight delays (including long distant phone calls), and missed connections to/from flights are beyond the control and responsibility of HSV. In addition, flight times are not guaranteed and may affect actual length of time on your vacation. Any flight information provided is considered tentative and subject to change, even after tickets have been issued. It is the sole responsibility of the vacation participant to reconfirm both outbound and return flights with their airline.

Per D.O.T. regulations regarding delays of public charter flights, airlines are no longer required by law to provide compensation for delays (i.e. rooms, meals or refunds), unless the delay is more than 48 hours. However, your Trip Cancellation and Trip Interruption Insurance has a benefit that just might help! HSV is not responsible for airline changes to their baggage policy, and advises tour participant to contact their airline prior to departure.

CANCELLATIONS:

Notice of cancellation must be received in writing by HSV to receive any refund, if applicable, on all our Vacations. No verbal cancellations will be accepted. Cancel fees start at \$100 per person, plus any additional imposed supplier fee(s). If the vacation participant can find a replacement, and there is still space available on the vacation, a refund, less a name change fee of \$100, plus any additional imposed supplier fee(s), will be given. Published airline tickets do not offer a cash refund, but rather a future credit. However, your Trip Cancellation and Trip Interruption Insurance has a benefit that just might help! Travel Protection fees are not refundable, nor are bounced check, declined credit cards, reinstatement/cancellation and reservation change fees.

TRIP PROTECTION:

All our vacation packages include Trip Cancellation and Trip Interruption Insurance. The cancellation protection does not cover you for any reason, but rather only covers you if you cancel due to unexpected, non-preexisting sickness or injury, plus protects against baggage loss, flight delays, medical interruption, as well as emergency service. Please click on the insurance link for a more detailed explanation of all this plan has to offer.

CUSTOMER SERVICE:

If you require assistance in any way while on your vacation, we suggest using the front desk staff at the hotel or cruise ship, who will usually provide assistance and solve your problem. If the problem can't be resolved there, please call the travel wholesaler. Their phone number will be printed on your travel documents. If they are unable to help you, call us. While we understand things come up that need to be addressed, High School Vacations is here to help make sure your trip runs as problem free as possible. If you're having a medical related problem, call the number on your insurance card. This card will be provided to you with your travel documents, and they are available for you 24 hours a day, 7 days a week. Under no circumstances will HSV reimburse you for long distance phone calls or other out of pocket expenses. If the matter cannot be resolved on location, then please write HSV within 60 days of the completion of your vacation. Failure to write HSV within this 60 day time period will release HSV from all claims and liability.

DOCUMENTATION:

U.S. Citizens are required to carry proper documentation of their proof of Citizenship when traveling out of the U.S. Only a valid Passport will be accepted for travel outside the United States. Birth certificates with raised seal, along with a driver's license, are no longer accepted. It's the sole responsibility of the vacation participant to obtain the proper documentation for travel. There are no refunds due to improper travel documents. If you are under 18 years of age, government regulations require a notarized letter signed by both parents giving permission for you to travel outside of the United States. If you have questions on the correct travel documents needed, please call us.

Non U.S. Citizens should consult their consulate for I.D. requirements. Airlines require all passengers to provide birth date, country of citizenship, form of I.D. that will be used for travel and emergency contact information. This information must be provided to HSV with your initial reservation. In all cases, this information must be provided no later than 10 days prior to departure OR you are subject to cancellation without refund.
